



Funding opportunity for DARE UK Community Groups: Working Group implementation

October 2024











1. Background

DARE UK Community Groups are collaborative environments established under the DARE UK programme's Community building, engagement & standards workstream to encourage different communities within the UK sensitive data research landscape to co-create components and pieces of work that align with the DARE UK programme's vision. With a focus on open communication and fostering the sharing of information and best practices, these groups will look to enhance sensitive data research and practice in the UK.

DARE UK Community Groups are modelled after similar groups at the <u>Research Data Alliance</u> and <u>IETF</u> and are established according to a charter outlined by the group conveners, which covers the 'why', 'what', and 'how' of each group. Each group will be subject to an endorsement process prior to set-up and will be guided by a <u>code of conduct</u> to ensure that community management best practices are upheld. The DARE UK Community Groups are open to anyone to propose, join and/or contribute to, and each serves a unique purpose.

There are two community group categories we fund: Interest Groups and Working Groups.

- Interest Groups are open-ended and focus on a broad-based challenge within the programme's scope. These groups will motivate Working Groups to address specific pieces of work. Illustrative examples of DARE UK Interest Groups include the UK TRE Community Management and Engagement Interest Group and Public Engagement in Data Research Initiative (PEDRI).
- Working Groups, on the other hand, are short-term (typically one year) in terms of their longevity and focus on specific, tractable pieces of work. The Al Risk Evaluation Working Group is one example of a DARE UK Working Group, producing a report on the development of safe Al in sensitive healthcare data. They are generally linked to an Interest Group but may come from anywhere, providing they are within the scope of the programme and the sensitive data research landscape the programme is aiming to serve.

The DARE UK programme is making up to £75,000 to enable capacity to support the activities of DARE UK Working Groups to produce specific, community-defined outputs over a period of not more than a year from February 2025 to the end of January 2026. These working groups will often, but not always, be scoped and brought together out of existing DARE UK Interest Groups.

Additional funding is also being made available to support Interest Group activities in a separate funding call. Please see <u>our website</u> for more details.

2. Purpose of DARE UK Working Groups

Drawing together a diverse network of researchers and relevant stakeholders, DARE UK Working Groups work together to:

- Take forward and produce specific outputs to address identified technical and governance barriers to enable better data connectivity and cross-domain analysis.
- Review, evaluate and make recommendations on different tools and technologies, data standards, or governance models for more secure and efficient cross-domain linkage and analysis of sensitive data.









• Organise community events and/or workshops to enable knowledge exchange and/or gain wider community and stakeholder input into Working Group outputs.

Examples of Working Group outputs include, but are not limited to:

- Recommendation documents/green papers
- Open-source software (including documentation)
- Metadata schema(s)
- Best practice standards
- Academic papers

We invite all those interested in sensitive data research to propose new Working Groups to collaboratively tackle specific, tractable challenges in support of the UK sensitive data research community.

3. Funding opportunity

Funds of up to £75,000 are now being made available for new **DARE UK Working Groups**, out of a total fund of £225,000. Funding will be provided for activities lasting no more than one year to be undertaken between February 2025 and the end of January 2026 and could be requested for activities such as the following:

- Salaries and overheads for Working Group management, coordination, and administration.
- Salaries and overheads for Working Group members' time to develop and produce the Working Group outputs.
- Workshops and events, including venue hire, travel, and subsistence.
- Support for communications and engagement activities for monitoring and dissemination of Working Group outputs and software licenses.

Please note that although anyone can propose to form a DARE UK Working Group, only those affiliated with eligible organisations can apply for funding.

4. Eligibility

Funding is available at 80% full Economic Cost (fEC) for all eligible organisations. More information on organisation eligibility can be found on the <u>UKRI website</u>.

5. How to apply

DARE UK Working Groups seeking funding to support their activities need to have completed a <u>Working Group Charter</u> and <u>funding application form</u>. Detailed guidance on what to include in these is described in the charter template and funding application form. 6. Selection criteria

Funding will be prioritised to Working Groups that bring together a new, diverse, and inclusive network of researchers and relevant stakeholders to achieve their goals through partnership working, evidenced by the inclusion of co-chairs from multiple organisations (at least two, but usually more) and including at least one public contributor (see Section 7 below) as well as broad-based representation amongst the wider group membership in the Working Group charter. Although the charter and funding application can be led by a subset of the group membership (for example, the co-chairs), we expect the plans to be co-developed with all members of the Working Group. Only applications that all members of the Working Group have been consulted on and support (please confirm the end of Q1 of the funding application form) will be considered for funding.

In addition to the need to demonstrate broad-based representation in the Working Group charter, we are particularly interested in funding applications that support partnerships working to address needs in areas including **but not limited to** the following:

- Technology/tool evaluation and comparisons in the (semi)-automation of Trusted Research Environment (TRE) operations (e.g. linkage of sensitive datasets by person, by place, etc.; privacy protection during data ingress; output checking).
- Reviews and recommendations of data standards (e.g. open metadata for automated discovery and cross-domain data interoperability)
- Reviews and recommendations of governance models (e.g. standardising researcher or TRE accreditation; risk tiering of TREs; managing digital federations)
- Reviews of and recommendations of cost-recovery and other funding models for TREs
- Defining effective public engagement strategies around building and running secure, trustworthy infrastructure and conducting open, transparent research using sensitive data.

Teams must be able to commence in February 2025 and complete all funded activities by the end of January 2026. Questions to be used by the selection committee for assessment are listed in the relevant section of the <u>funding application form</u> and will be assessed according to the <u>scoring criteria</u>.

Selection will be based on the scoring criteria until the maximum funding is allocated, taking into account the portfolio of Working Group funding proposals with a balanced overall spread across the strategic themes outlined above.

7. Public involvement and engagement

DARE UK is committed to meaningful public involvement and engagement. For DARE UK-funded Working Groups, this must include public involvement in Working Group governance structures, with plans for at least one public contributor to participate as a Working Group co-chair. In addition to public involvement in Working Group governance, Working Groups must also include plans to undertake other kinds of public involvement and engagement activities, such as:

- workshops and focus groups with members of the public to seek public input into the Working Group's output(s)
- input of public contributors to review Working Group descriptions and outputs

Public involvement and engagement (PIE) plans should be clearly embedded into project timelines and fully cost into project proposals. There is no upper limit for the proportion of the award that can be dedicated to public involvement and engagement, with a typical expectation of ~10% allocation to PIE, depending on the nature of the work being undertaken.

8. Timeline

- 2 October 2024: Funding opportunity opens.
- 15 October 2024: Public webinar and Q&A about the funding opportunity
- 19 November 2024: Funding opportunity closes.
- w/c 16 December 2024: Funding decisions communicated to applicants.
- 3 February 2025: Funded Working Group activities commence.
- July 2025: Mid-point project report and check-in meeting to discuss progress and identify any bottlenecks.
- January 2026: Final short report due detailing Working Group progress and outputs.
- End January 2026: Funded Working Group activities end.
- March 2026: DARE UK Community Group annual plenary event.
